

### Environmental Issues

#### **Earth hazards**

- 1 Study **Fig. 1**, which shows a mass movement, North Yorkshire, April 2008.

Outline a geographical issue indicated and suggest appropriate strategies for its management. [10]

#### **Ecosystems and environments under threat**

- 2 Study **Fig. 2**, a cartoon about ecosystems and environments under threat.

Outline a geographical issue indicated and suggest appropriate strategies for its management. [10]

#### **Climatic hazards**

- 3 Study **Fig. 3**, which shows the number of days in January 2010 with snow lying, compared to the average for that month.

Outline a geographical issue indicated and suggest appropriate strategies for its management. [10]

### Economic Issues

#### **Population and resources**

- 4 Study **Fig. 4**, which shows the global pattern of population under age 15 years, 2012.

Outline a geographical issue indicated and suggest appropriate strategies for its management. [10]

#### **Globalisation**

- 5 Study **Fig. 5**, which shows political and economic groupings in North and South America.

Outline a geographical issue indicated and suggest appropriate strategies for its management. [10]

#### **Development and inequalities**

- 6 Study **Fig. 6**, which shows the relationship between income per person and life expectancy.

Outline a geographical issue indicated and suggest appropriate strategies for its management. [10]

## SECTION B

Answer **two** questions, selecting **one** from **Environmental Issues** and **one** from **Economic Issues**.

### Environmental Issues

Answer **one** of the following questions.

#### **Earth hazards**

- 7 Assess the extent to which flood risk results from human rather than physical factors. [30]
- 8 How significant is the level of economic development of an area in determining the impacts of earth hazards? [30]

#### **Ecosystems and environments under threat**

- 9 ‘The consequences of human activities for physical environments and ecosystems are rarely anticipated.’ Discuss. [30]
- 10 To what extent are physical components more important than human components in ecosystems? [30]

#### **Climatic hazards**

- 11 ‘The impacts of climatic hazards depend on the physical geography of the location affected.’ How far do you agree with this view? [30]
- 12 ‘Climatic hazards are relatively straightforward to predict.’ Discuss. [30]

### Economic Issues

Answer **one** of the following questions.

#### **Population and resources**

- 13 ‘The sustainable management of resources is becoming increasingly difficult.’ Discuss. [30]
- 14 ‘Overpopulation brings more challenges than underpopulation.’ How far do you agree? [30]

#### **Globalisation**

- 15 Evaluate the extent to which the social impacts of globalisation are only advantageous. [30]
- 16 To what extent does the structure and direction of a country’s trade affect whether it benefits from globalisation? Discuss. [30]

#### **Development and inequalities**

- 17 ‘Core areas create only advantages.’ Discuss. [30]
- 18 To what extent do inequalities within **either** a named region **or** city result from economic factors? [30]
